



Online Privacy Policy

Save the Family Foundation of Arizona values its user's privacy. This policy describes the ways that identifying personal and anonymous information about you is gathered, stored, and shared, and how you may request that information as well as decline and or change the information provided to the agency for internal and public use.

Your Personally Identifying Information

Save the Family Foundation of Arizona, respects the privacy of any personal information you entrust to us. This Privacy Policy applies to both our online and offline collection of personal information. We may collect identifying personal information from you in several situations. For example, when you contact us for information, provide feedback about our services, sign up for our services, participate in an agency survey or any organization platform, or otherwise communicate with us. If you do not agree to the terms and conditions of this Privacy Policy, please do not use our website or services to provide identifiable information.

The personal information we may collect includes:

- Contact information, such as your name, mailing address, email address, and telephone number.
- Preferences information such as Agency resources offered.
- Geolocation information.
- Online identifiers, such as username and IP address.
- Use - information, such as how you and your device interact with our website (e.g., the pages you visited, the search terms you entered).
- Additional information you may provide to us in your communications or in connection with our Services, including birthdate, gender, and photographs containing images of you.

Please note that we define "identifying personal information" as information that can be used to identify, locate or contact you. It also includes other information that may be associated with your personal information, such as your internet connection, the equipment you use to access our website and usage details.

Log Files

Save The Family Foundation of AZ and Agency partners may collect certain information by automated means when you use our web services, including your internet protocol ("IP") address; information about your web browser software and version; if you arrive at the website services through a link from another website, the uniform resource locator ("URL") of the linking page; your mobile device identifier and other technical information about devices you use to access the Services, and information about your activity while using the Services, such as which pages you choose to view, queries you make using our "search" function, and other information about your website usage.



We do not link this automatically collected data to other information we collect about you, however it is to inform you that it may be collected and stored.

Use of Information Collected

We use the information we collect from you for the following purposes:

- To send you marketing, fundraising and agency update communications.
- To respond to your requests and inquiries.
- To improve user experience by making our website easier to use and navigate.
- For other legitimate business purposes only as approved by agency management.

SMS Consent and Phone Numbers:

Your phone number and SMS consent are collected solely for the purpose of communication directly between you and Save the Family Foundation of Arizona. **We do not share phone numbers or SMS consent with any third parties or affiliates.**

Information We Share

Statistical Reports and Analysis

Statistics reported that describe our online audience, which is often based on the information you provide when you browse our sites, this helps us publicize Save The Family Foundation of Arizona. We may allow third parties to collect information in order to provide us with analytics. The information we share under these circumstances is anonymized and does not contain behavioral or identifying information about any individual user, unless that individual has given us their prior consent to share that information.

Retention Time

Personal information is kept for the time necessary to provide the service requested by you, or stated by the purposes outlined in this document, and you can always request that we suspend the use of your personal information or request that it be deleted.

Your Personal Information Rights

Right to opt Out or Stop Processing

You can always limit the information you provide to us. You can also limit the communications that we send to you. To opt-out of emails, phone calls, text messages or to stop the processing of your personal information, simply email the agency with your request to (info@savethefamily.org). Please note that even if you opt-out of Agency communication, we may still need to contact you directly should you have any continuing business, financial or resource connections or obligations with the agency.

We may not accommodate a request to change information if we believe the change would violate any law or legal requirement or cause the information to be incorrect. Proper access and use of information provided on the website is governed by our terms of use.

Third Party Websites

It is our policy to post any changes we make to our privacy policy on this page. If we make material changes to how we treat your personal information, we will notify you through a notice on the website homepage. The date the privacy policy was last revised is identified on this page. You are responsible for ensuring we have an up-to-date active and deliverable contact information for you, and for periodically visiting our website and this privacy policy to check for any changes. If the changes we seek to implement will materially affect the



way we use or disclose previously collected personal information; we will notify you about the change before it goes into effect by sending a notice to the primary email address associated with you.

Co-Branded Sites and Services

When you use a co-branded service within our network of sites or provide information on a co-branded site, you grant us permission to pass the information collected back to that service or site partner. Their use of your information is subject to their applicable privacy policies.

Children's Privacy

Our Services are not specifically directed to persons under the age of 18. We do not knowingly collect personally identifiable information from children under 18 years of age. If a parent or guardian becomes aware that his or her child has provided us with personal information without their consent, he or she should contact us via the contact details listed. If we become aware that a child under the age of 18 has provided us with personal information, we will delete such information from our files. By using our services, you certify that you are not under the age of 18 when providing identifiable information.

Media

If you upload images to the agency website, you should avoid uploading images with embedded location data (EXIF GPS) included. The agency is not responsible if visitors to the website can download and extract any location data from images on the website.

Security

The security of our client and partners' information is important to us. We maintain reasonable security procedures to help protect against loss, misuse or accidental or unauthorized access, disclosure, alteration or destruction of the information you provide through our Services. While we strive to protect your personal information and privacy, we cannot guarantee the security of any information you disclose or transmit to us online and cannot be responsible for theft, destruction, or inadvertent disclosure of your personal information.

SMS Sharing of Information - STF will not rent or sell your Personal Information, including your phone number, to other companies or individuals unless we have your consent. From time to time, we may share aggregated or de-identified information about use of the Messaging Service and such aggregated or de-identified information may be shared with any third party, including advertisers, promotional partners, and sponsors at which point you would be subject to their own privacy policy and SMS terms and conditions.
